The Business Development Division evaluated three bids submitted for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had limited M/WBE availability. As a result, the M/WBE goal was reduced from 25% to 15%. At the time of bid opening, at least 99 firms were certified to provide the scope of services at the subcontract level.

The apparent low bid, submitted by Poli Construction Inc., reported 10.68% in M/WBE participation. The apparent low bid did not meet the Orange County M/WBE participation goal per the Ordinance requirement.
