RECOMMENDATION:

Selection of one firm and two ranked alternates to provide Engineering Services for Eastern Water Reclamation Facility (EWRf) Phase 6A Plant Reclaimed Water System Expansion, Request for Proposals Y19-818-TA, from the following firms listed alphabetically. Further, request the Board authorize negotiation and execution of a contract by the Procurement Division provided that that the contract does not exceed the budget of \$3,000,000.

The Procurement Committee evaluated the proposals on July 10, 2019. Commissioner Victoria P. Siplin was assigned to the Procurement Committee.

PURPOSE

This project consists of the design, permitting, and construction administration for the Eastern Water Reclamation Phase 6A Plant Reclaimed Water System Expansion. The project includes replacement of the existing phase I and II effluent pumps with higher head pumps to feed the facility at higher flow rates, installation of three reclaimed water storage tanks, one new high service pump station with four 350 HP pumps, a bridge crane, electrical equipment connection to emergency power, flow meter station, site improvements, and piping and valve modifications to interconnect with Orange County Utilities and City of Orlando and to allow the phase III effluent pump station to feed the facility. The work is located in District 4.

DISCUSSION

Five proposals were received in response to the Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in the RFP. Consensus scores from the Procurement Committee are attached.
