## **RESOLUTION GRANTING CORRECTED PETITION TO VACATE # 23-05-018**

WHEREAS, pursuant to procedures adopted by the Board of County Commissioners, a petition was filed with the Board to vacate that certain 4-foot-wide portion of a 20-foot-wide drainage easement that lies near the west property line of her residential lot located in the Brighton Woods Subdivision containing approximately 258 square feet in Orange County, Florida, as described in attachment.

WHEREAS, notice of a public hearing before the Board of County Commissioners on April 23, 2024, was published in the *Orlando Sentinel*, a newspaper of general circulation in Orange County, Florida, one time at least two weeks prior to the date for the hearing; and

WHEREAS, the Board finds that the vacating of the 4-foot-wide portion of a 20-foot-wide drainage easement that lies near the west property line of her residential lot located in the Brighton Woods Subdivision containing approximately 258 square feet will not operate to the detriment of Orange County or the public.




