Subject: Award of Invitation for Bids Y23-1009-MB, Cold In-Place Bituminous Recycling
with Asphalt Resurfacing

ACTION REQUESTED:

Approval to award Invitation for Bids Y23-1009-MB, Cold In-Place Bituminous Recycling with Asphalt Resurfacing, to the sole responsive and responsible bidder, Asphalt Paving Systems, Inc., in the estimated contract award amount of \$6,702,100 for a one-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

PROCUREMENT:

Work under this contract will consist of providing all labor, materials and equipment necessary to perform cold in-place bituminous base recycling with asphalt resurfacing of existing and new resurfaced roadways to reclaim the integrity of the roadway base structure in accordance with Florida Department of Transportation and Orange County standards. Work will be issued on an as needed basis throughout the county. The project is located in all districts.

FUNDING:

Funding is available in account number 1004-072-2990-3816.

APPROVALS:

The Roads and Drainage and Business Development Divisions concur with this recommendation.

REMARKS:

One bid was received in response to this Invitation for Bids and was evaluated for responsiveness and responsibility, and price reasonableness. Staff determined that the bid from Asphalt Paving Systems, Inc., is considered reasonable for this type of work based on marked factors and specialized fuel work. References provided by Asphalt Paving Systems, Inc., were verified and satisfactory for this type of work. Therefore, the award is recommended to Asphalt Paving Systems, Inc.

**PROJECT: Y23-1009-MB, Cold In-Place Bituminous Base
Recycling with Asphalt Resurfacing**

The Business Development Division evaluated the one bid submitted for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had limited M/WBE availability. As a result, the M/WBE goal was reduced from 24% to 5%. At the time of bid opening, at least seven firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, submitted by Asphalt Paving Systems, Inc. reported 5.2% in M/WBE participation and met the Orange County M/WBE participation goal of 5% **per Ordinance**. Please note the following certified M/WBE participation:

Our evaluation of this bid was based on the participation listed on the Contract and Sub-Contract Goal Participation Schedule. Attached is a spreadsheet reconciling the bidders' compliance with the Invitation for Bid's M/WBE requirements, including the percentage breakdown for the bidder and a comparison of the relative bids versus participation percentages.
