SUBJECT: Award of Invitation for Bids Y19-1009-TA, Lateral CIPP Lining Term Contract

ACTION REQUESTED:

Approval to award Invitation for Bids Y19-1009-TA, Lateral CIPP Lining Term Contract, to the low responsive and responsible bidder, BLD Services LLC, in the estimated contract award amount of \$594,275 for the base year. Further request authorization for the Procurement Division to exercise contract option years one and two.

PROCUREMENT:

The work includes furnishing all labor, equipment, and materials for cleaning and televising sewer mains and laterals, installation of CIPP liner systems, rehabilitation and reconnection of existing service laterals, and CCTV inspection before and after rehabilitation work. Work includes all associated site work and restoration.

APPROVALS:

The Field Services Division and the Business Development Division concur with this recommendation.

REMARKS:

Four bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. BLD Services LLC has a satisfactory record of performance and is considered responsible. Therefore, award is recommended to BLD Services LLC.

SUBJECT: Business Development Division Bid Evaluation

PROJECT: **Y19-1009-TA, Lateral CIPP Lining**

The Business Development Division evaluated the 3 lowest bids of the 4 bids submitted for this project and found that the apparent low bidder, BLD Services LLC, did not meet the Orange County M/WBE participation goal of 25%. They reported 0% M/WBE participation in their bid and did not provide good faith effort documentation.

The second low bid submitted by Miller Pipeline, LLC did not meet the Orange County M/WBE participation goal of 25%. They reported 2% M/WBE participation in their bid and did not provide good faith effort documentation. Please note the following certified M/WBE participation:

The third low bid submitted by National Water Main Cleaning Company did not meet the Orange County M/WBE participation goal of 25%. They reported .44% MWBE participation in their bid and did not provide good faith effort documentation. Please note the following certified M/WBE participation:

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.
