RECOMMENDATION:

Selection of Consultants, Request for Proposals Y22-115-WW, Outpatient Ambulatory Health Services for Persons with HIV (Ryan White Part A), with AIDS Healthcare Foundation, Inc. for Lot 1, in the overall total annual amount of \$1,998,254 for a one-year term, Florida Department of Health, Orange County for Lot 1 in the overall total annual amount of \$1,147,958 for a one-year term, Midway Specialty Care Center, Inc. for Lot 1, in the overall total annual amount of \$82,500 for a one-year term, Florida Department of Health, Osceola County for Lot 2, in the overall annual amount of \$500,000 for a one-year term, Florida Department of Health, Seminole County for Lot 3, in the overall total annual amount of \$398,761 for a one-year term, and Florida Department of Health, Lake County for Lot 4, in the overall total annual amount of \$303,000 for a one-year term. Further request authority for the Procurement Division to renew each contract for four additional one-year terms.

Request authorization for the Procurement Division to renew contracts for four additional one-year renewals.

The proposals were evaluated by the Procurement Committee on May 18, 2022. Commissioner Maribel Gomez Cordero was assigned to the Procurement Committee.

PROCUREMENT:

These contracts will disperse federal grants funds from U. S. Health Resources and Services Administrator (HRSA) to agencies for provision of health and support services for people with HIV.

FUNDING:

Funding is available in account number 7012-060-7302-8610. Funding is provided via a federal grant from HRSA.

APPROVALS:

The Health Services Department concurs with this recommendation.

DISCUSSION:

The Ryan White Program is a health and support program for people with HIV. The County administers the program under guidelines from HRSA and is the designated grantee for funding. The grantee establishes the HIV Planning Council, conducts the process to distribute funds, distributes funds re-allocated by the Planning Council, and executes and monitors contracts.

The Central Florida HIV Planning Council designs the service delivery system for persons served with Ryan White Part A funding in the Orlando Eligible Metropolitan Area (EMA). The program covers an EMA that consists of Orange, Osceola, Lake and Seminole Counties. The service delivery system is established through the selection, prioritization, and allocation of funding among those services and by providing direction to the Grantee on "Ways to Best Meet Need."

Proposals were received from six agencies in response to the Request for Proposals. The proposals were evaluated by the Procurement Committee, and the recommendation was to award contracts to all proposers in the following service categories:

Lot 1: Florida Department of Health, Orange County, AIDS Health Foundation, Inc., and Midway Specialty Care Center, Inc.

Lot 2: Florida Department of Health, Osceola County

Lot 3: Florida Department of Health, Seminole County

Lot 4: Florida Department of Health, Lake County
