ACTION REQUESTED:

Approval to award Invitation for Bids Y22-1048-GO, Waste Removal and Recycling Services for the Orange County Convention Center, to the low responsive and responsible bidder by lot, Waste Connections of Florida, Inc., in the estimated contract award amount of \$21,463,750 for a five-year term. Further request authorization for the Procurement Division to renew the contract for three additional one-year terms.

PROCUREMENT:

This contract will provide waste removal and recycling at the Orange County Convention Center (OCCC). In support of Orange County's Sustainable Operations and Resilience Action Plan, and the OCCC's Sustainability Action Plan, the OCCC is committed to conducting its operations in an environmentally responsible manner through the establishment of an environmental management system.

FUNDING:

Funding is available in account number 4430-035-0927-3735 and 4430-035-0927-3610.

APPROVALS:

The Orange County Convention Center and Business Development Division concur with this recommendation.

REMARKS:

Two bids were received in response to the Invitation for Bids. The bids were evaluated for price, responsiveness, and responsibility. Waste Pro of Florida was deemed non-responsive for failing to submit required documents. The bid submitted
