ACTION REQUESTED:

Ratification of Contract Y20-120-KB, Head Start Child Care Food Program, to the sole responsive and responsible bidder, Second Harvest Food Bank of Central Florida, Inc. dba Meals for Good, in the total contract award amount of \$1,185,668.86.

PROCUREMENT:

This contract provides meals (breakfast, lunch, and afternoon snacks) to all Head Start locations for the period of October 1, 2019 through September 30, 2020.

FUNDING

Funding is available in accounts 7408-062-7524-4135 and 7008-062-7522-4135. Funds for this program are reimbursed by the State of Florida.

<u>APPROVALS:</u>

The Head Start Division concurs with this recommendation.

REMARKS:

One bid was received in response to this Invitations for Bids and was evaluated for price reasonableness, responsiveness, and responsibility. As part of the reimbursement parameters, the State of Florida required the formal solicitation opportunity to be limited to the six state approved caterers. Five of the state approved caterers responded with a declaration of no bid.

In accordance with the State of Florida Bureau of Child Care Food Programs' written directives, award is recommended to the sole responsive and responsible bidder Second Harvest Food Bank of Central Florida, Inc. dba Meals for Good. Price reasonableness has been determined based on comparison to the current contracted pricing. The new contract will reflect a 6% decrease in pricing, with no change to scope.
