Re: Request Number **M23-001** for Approval of the Notice of Intent Resolution

Applicant: Special Assessments

Type of Hearing: To request approval of the Notice of Intent Resolution to use the Uniform Ad Valorem Method of Collection of Non-Ad Valorem Assessments for properties not yet scheduled for public hearings for proposed Municipal Service Benefit Units (MSBU's).

Hearing Required by F. S.# Florida Statute Sections 197.3632 and 125.01 (01) (q). **The resolution must be approved by March 1, 2023 to provide the means by which proposed special assessments may be included on the November 2023 real estate tax bill.**

Advertising Requirements / Timeframe: Publish in a newspaper of general circulation four (4) consecutive weeks prior to the date of the public hearing using a display ad.

Notify Abutters: N/A.

Estimated Time Required: One (1) minute.

District: All districts.

Hearing Controversial: No.

Report: Certain individuals, developers, and / or associations have requested the establishment and / or the amendment of the Municipal Service Benefit Unit (MSBU) as detailed in Exhibit "A" and Exhibit "B". The purpose of the hearing is to assure that, if the MSBU's are approved individually at separate public hearings, it will be possible to include them with the November 2023 real estate tax bill.

If the Board of County Commissioners (Board) approves this proposal, it is approving only the means by which it will collect special assessments imposed by the MSBU's. The special assessments would be imposed only at a second public hearing held prior to June 1, 2023. The Board will retain its prerogative to establish and / or to amend or not to establish and / or not to amend the MSBU's and to impose or not to impose any special assessments.

This hearing is a formality to reserve the Board's prerogative to place MSBU special assessments, if any, on the real estate tax bill for this November.

NOTICE OF INTENT November 2023

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA DECLARING THE BOARD'S INTENT TO USE THE UNIFORM METHOD OF COLLECTING NON-AD VALOREM SPECIAL ASSESSMENTS AS AUTHORIZED BY SECTION 197.3632, FLORIDA STATUTES; AS THE METHOD OF PROVIDING STREETLIGHTING, RETENTION POND DRAINAGE SERVICES, LAKE CLEANING SERVICES, LOT CLEANING FEES, AND / OR CONSTRUCTION OF CENTRAL GRAVITY SEWER SYSTEMS DECLARING THE NEED FOR SUCH NON-AD VALOREM SPECIAL ASSESSMENTS; AND DESCRIBING THE BOUNDARIES OF THE LAND THAT WILL BE SUBJECT TO SUCH NON-AD VALOREM SPECIAL ASSESSMENTS

WHEREAS, the Orange County Board of County Commissioners ("Board") has been asked to consider establishing and/or amending Municipal Service Benefit Units ("MSBU") in portions of Orange County for the purpose of providing streetlighting, retention pond drainage services, lake cleaning services, lot cleaning fees, and / or construction central gravity sewer systems.

WHEREAS, a non-ad valorem special assessment is the preferred means to fund the MSBU's to pay the annual expense of such streetlighting, retention pond drainage services, lake cleaning services, lot cleaning fees, and / or construction of a central gravity sewer systems; and

WHEREAS, Section 197.3632, Florida Statutes; grants Orange County the power to impose and collect non-ad valorem special assessments using a uniform method prescribed therein; and

WHEREAS, Subsection 197.3632 (3), Florida Statutes; requires the Board to adopt a resolution, prior to March 1, which declares the Board's intent to use the Uniform Method of collecting such non-ad valorem special assessments.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

1. The Board hereby declares its intent to use the Uniform Method of collecting non-ad valorem special assessments authorized by Section 197.3632, Florida Statutes; per Exhibit "A," for the purpose of providing streetlighting, retention pond drainage services, lake cleaning services, lot cleaning fees, construction of central gravity sewer systems as contemplated by Section 125.01 (1) (q), Florida Statutes. The Board declares further that the levy of non-ad valorem special assessments against these properties is needed to provide funds to pay the cost of such streetlighting, retention pond drainage services, lake cleaning services, lot cleaning fees and / or construction of a central gravity sewer systems in order to ensure the health, safety, and welfare of the residents.

2. The boundaries of the real properties that will be subject to such non-ad valorem special assessments are described in Exhibit "A" and Exhibit "B" in this Resolution.

3. The Clerk to the Orange County Board of County Commissioners is hereby authorized and directed to send a copy of this Resolution by United States Mail to the Orange County Property Appraiser, the Orange County Tax Collector, and the State of Florida Department of Revenue no later than March 10, 2023.

4. This Resolution shall take effect immediately.
