Background

▪ History of the Ocoee JPA

- February 11, 1994 until February 10, 2019
- Current JPA agreement with the City of Ocoee December 2019
 - First Amendment Approved November 30, 2021
 - Low Density Residential to Industrial
 - Second Amendment Approved November 30, 2021
 - Professional/Office to Commercial
 - Third Amendment Approved September 27, 2022
 - Low Density Residential to High Density Residential

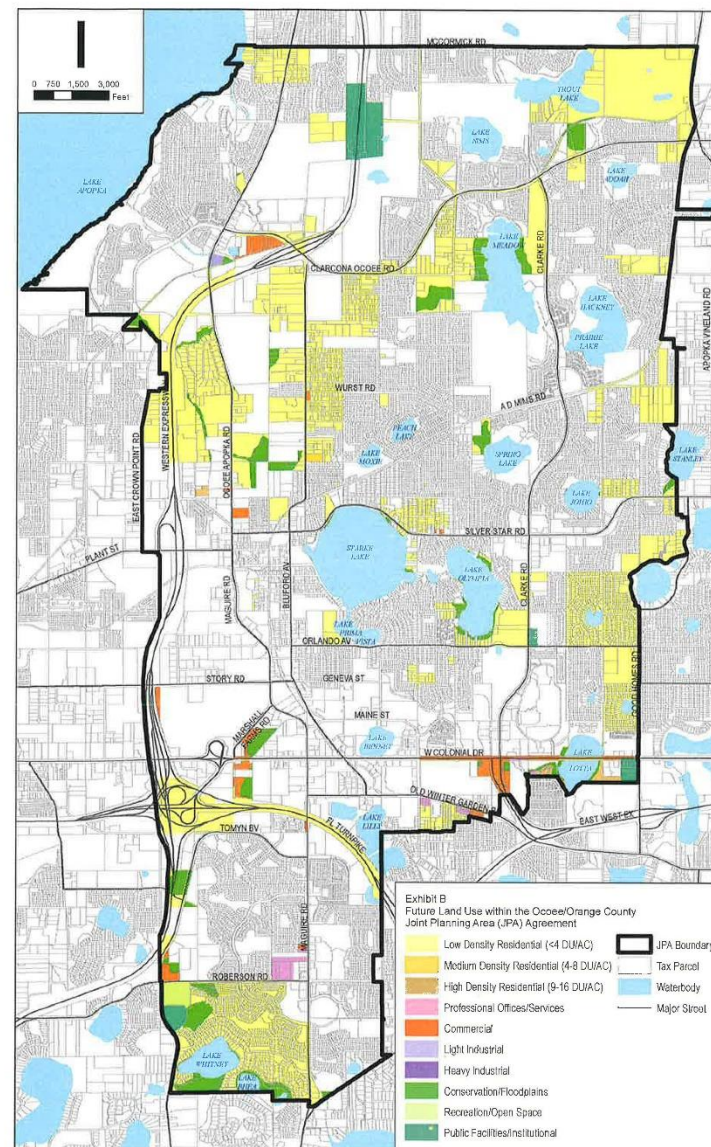


Provisions

- **Provisions of the JPA**
 - Effective for 5 years and automatically extended for 5 years
 - Exhibit A establishes the lands that are part of the JPA
 - Exhibit B Future Land Use Map with agreed upon designations intended to **apply upon annexation** of the land into the City of Ocoee
 - Annexation of enclaves process (Map C)
 - Notification requirements



Adopted Exhibit B – Land Use Map

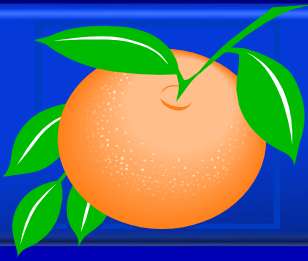






4th Amendment, JPA Agreement: Orange County/City of Ocoee

Location:	7 parcels: 1053, 1059, 1305, 1113 Ocoee Apopka Road and 1102, 1104 North Lakewood Avenue, generally located west of North Lakewood Avenue, south of Fullers Cross Road, and east of Ocoee Apopka Road.
Acreage:	~17.87 gross acre
From:	Low Density Residential
To:	Commercial
Proposed Use:	150-acre Ocoee Regional Sports Complex project, which will include sports fields, retail, restaurant, hotel, civic/assembly, office, indoor sports, and other commercial uses
District:	2

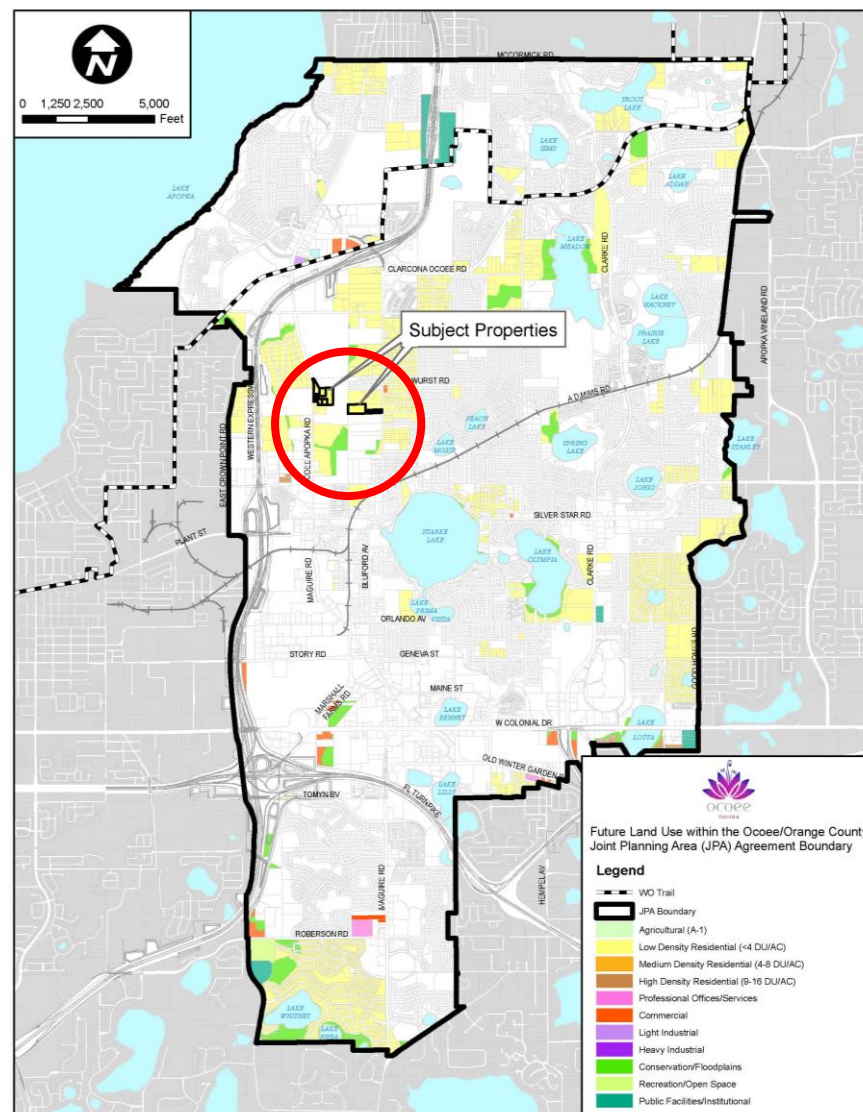
