ACTION REQUESTED:

Approval to award Invitation for Bids Y19-758-RM, Oakview Drive Drainage Improvements Project, to the low responsive and responsible bidder, Valencia Construction Group, Inc. in the total contract award amount of \$490,768.

PROCUREMENT:

Work under this contract consists of re-grading the gutter within the cul-de-sac, re-shaping the cul-de-sac grades, constructing new curbs inlets manholes, and upgrading the pipes sizes along the existing system from the cul-de-sac. The project is located in District 3.

FUNDING:

Funding is available in account number 1004 072 3010 6330.

APPROVALS:

The Roads and Drainage and Business Development Divisions concur with this recommendation.

REMARKS:

Six bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Although the bid submitted by Valencia Construction Group, Inc. is approximately 5% lower than the estimate, staff evaluated the bids, and the bid is considered reasonable. References provided were satisfactory for this type of work and Valencia Construction Group, Inc. has been determined to be responsible. Therefore, award is recommended to Valencia Construction Group, Inc.

SUBJECT: Business Development Division Bid Evaluation

PROJECT: Y19-758-RM / Oakview Drive Drainage Improvements Project

The Business Development Division evaluated the three lowest bids of the six bids submitted for this project. One of the bidders was an Orange County certified M/WBE. The scope of services for the Oakview Drive Drainage Improvements Project had M/WBE availability at the prime and sub-contract level. At the time of bid opening, at least 34 M/WBE firms were certified to provide piping, concrete, sod, and asphalt services.

The apparent low bidder Orange County Minority/Women Business Enterprise firm Valencia Construction Group, Inc. is bidding as a prime. Therefore, Valencia Construction Group, Inc. is required to self-perform no less than 51% of the contract per Sec. 17-321 in the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 25% M/WBE goal. Valencia Construction Group, Inc. reported self-performing 99.84%. They met the M/WBE participation goal. Please note the following certified M/WBE participation:

The second low bid, submitted by Condor Construction, Corp., did not achieve good faith effort documentation and reported 12.15% M/WBE participation in their bid.

The third low bid, submitted by Boromei Construction, Inc., did not achieve good faith effort documentation and reported no M/WBE participation in their bid.

None of the bids met the M/WBE sliding scale range criteria to be awarded this contract over the low bidder.
