ACTION REQUESTED:

Approval to award Invitation for Bids Y23-790-GO, International Drive Traffic Signal Projects, to the low responsive and responsible bidder, Traffic Control Devices, LLC in the total contract award amount of \$2,595,595.

In the event the bidder recommended above fails to achieve timely compliance with pre-award deliverables, as defined in the Invitation for Bids, including, but not limited to, M/WBE participation sub-contract agreements, State Division of Corporations registration, E-verify, insurance and bonds, further request authorization for the Procurement Division to award to the next low responsive and responsible bidder as listed in the bid tabulation herein, to the extent practicable and advantageous to the County.

PROCUREMENT:

Work under this contract consists of supplying and installing three traffic signal projects within the International Drive Community Redevelopment Area to enhance safety for the traveling public. This project is located in District 6.

FUNDING:

Funding is available in account number 1246-072-5095-6320.

APPROVALS:

The Traffic Engineering and Business Development Divisions concur with this recommendation.

REMARKS:

Two bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Traffic Control Devices, LLC has a satisfactory record of performance for this type of work and has been determined to be responsible. Therefore, award is recommended to Traffic Control Devices, LLC.

PROJECT: Y23-790-GO / I-Drive Traffic Signal Projects

The Business Development Division evaluated the two bids submitted for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had limited M/WBE availability. As a result, the M/WBE goal was reduced from 25% to 9%. At the time of bid opening, at least 51 firms were certified to provide the scope of services at the subcontract level.

The apparent low bid, submitted by Traffic Control Devices, LLC, reported 9.01% in M/WBE participation. The low bid met the Orange County M/WBE participation goal **per the Ordinance requirement**. Please note the following certified M/WBE participation:

The second low bid, submitted by The New Florida Industrial Electric, Inc., reported 9.32% in M/WBE participation.

Business Development issued a Submittal of Clarification email request on May 8, 2023, for the second low bidder to submit:

- Prime Contractor's scope of Services, scope of classification, and dollar amount omitted on the Contract and Sub-Contract Goal Participation Schedule form
- Good Faith Effort Form Action #1, #2, #3, #4, and #5.

On May 10, 2023, the second low bidder provided no response.

Therefore, no additional M/WBE participation can be included. The M/WBE participation will remain at 9.32%. The second low bid met the Orange County M/WBE participation goal **per the Ordinance requirement.** Please note the following certified M/WBE participation:
