Applicant: Adam Smith, VHB, Inc., Waterleigh Planned Development / Waterleigh Phase 3 Preliminary Subdivision Plan, Case # PSP-17-10-324. Consideration: Waterleigh Planned Development / Waterleigh Phase 3 Preliminary Subdivision Plan, Case # PSP-17-10-324, submitted in accordance with Orange County Code, Sections 38-1381, 34-69 and 30-89; This Preliminary Subdivision Plan (PSP) is a request to subdivide 355.02 acres in order to construct 709 single-family residential dwelling units. This request also includes the following waivers from Orange County Code: 1.) A waiver from Orange County Code Section 34-152(c) is granted to allow lots to front a new (park, open space, or similar space), in lieu of the 20' access to a dedicated public paved street. Legal access to these lots shall be through an ingress/egress easement and/or alley tract; 2.) A waiver from Orange County Code Section 38-1384(1)(4) is granted to allow lots greater than 50' in width that face neighborhood squares and park to be front loaded in lieu of access from a rear alley or from a rear-yard garage.
