WHEREAS, the Board of County Commissioners of Orange County (the "Board") is authorized enact, and from time to time, amend fees charged by the various departments and divisions for Orange County for various services rendered to the public; and

WHEREAS, the Board adopted and established a schedule for certain fees related to tree protection and removal applications and their processing for inclusion in the Fee Directory on December 18, 2001, pursuant to Resolution 2001-M-54; and

WHEREAS, recent amendments to the Orange County Tree Protection and Removal Ordinance, Chapter 15, Article VIII, Orange County Code, require the Board to revise several fees and establish several new ones related to the implementation of the ordinance.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. Revised Fee Schedule. The Board hereby adopts the revised fee schedule, attached to and incorporated in this Resolution as Exhibit "A". For the fees identified herein, the attached schedule supersedes and replaces Resolution 2001-M-54. once this Resolution becomes effective.

Section 2. Severability of Provisions. If any provision of this Resolution or the application thereof to any person or circumstances is held invalid, the invalidity shall not

affect other provisions or applications of this Resolution, which can be given effect without the invalid provision or application, and to this end the provisions of the Resolution are declared severable.

Section 3. Effective Date. This Resolution shall take effect on March 15, 2024.
