DISCUSSION AGENDA ITEM DECEMBER 19, 2017

The terms of two of the members of the Planning and Zoning Commission (P&Z), Yog Melwani and Jose Cantero, will expire on December 31, 2017. Both Mr. Melwani and Mr. Cantero are eligible for another term and wish to continue serving on the P&Z.

The P&Z is composed of nine members, one appointed from each of the county commission districts upon recommendation of the district commissioner, one appointed upon recommendation of the County Mayor, and two at large members nominated by the County Mayor or any County Commissioner and appointed by the full Board. The Board must confirm all appointments. Members of the P&Z are limited to four consecutive terms. The terms are effective January 1, 2018 and are for two years.

Attached is a list of the current members of the P&Z that indicates the districts in which the members reside, the categories in which they were appointed, and the expiration of their terms. I have also attached for your review a list of all applications on file for appointment to this board.
