### **RECOMMENDATION:**

Selection of Shauna M. Laughna dba Laughna Consulting to provide Psychological Services for Corrections New Hires for the Corrections Department, Request for Proposals Y22-154-KB. Request authorization for the Procurement Division to negotiate and execute a one-year contract, within a budget of \$108,495. Further request authorization for the Procurement Division to renew the contract for four additional one-year terms.

The proposal was evaluated by the Procurement Committee on June 22, 2022. Commissioner Emily Bonilla was assigned to the Procurement Committee.

#### PURPOSE:

This contract will provide psychological screening and evaluations for Correction Officer applicants for employment within the Corrections Department.

#### **DISCUSSION:**

The Corrections Department examines approximately 325 correctional applicants annually on a continuous, uninterrupted basis. Corrections requires a psychologist to screen and evaluate applicants by interviewing and objective testing to provide an assessment of the applicant's suitability for employment in the public safety field. The proposal submitted by Shauna M. Laughna dba Laughna Consulting is 8% higher than the current County contract Y17-1049, which is determined to be fair and reasonable.

One proposal was received in response to the Request for Proposals (RFP). To ensure an open and competitive process, the RFP was posted on the County's e-procurement solution. A query from staff to potential sources that declined to compete on this project resulted in the following:

The procurement committee evaluated the proposal in accordance with the criteria established in the RFP. Consensus scores of the Procurement Committee are attached.
