You are invited to attend and be heard regarding the following proposed ordinance:

AN ORDINANCE CONCERNING ANIMAL SERVICES AND DANGEROUS DOG PROCEEDINGS IN ORANGE COUNTY, FLORIDA; AMENDING SECTIONS 5-29, 5-31, 5-32, 5-32.1, AND 5-50 OF ORANGE COUNTY CODE TO PROVIDE ADDITIONAL PROCEDURAL DUE PROCESS REQUIREMENTS FOR CLASSIFICATION OF DOGS AS DANGEROUS; AMENDING THE DEFINITION OF A DANGEROUS DOG AND PROPER ENCLOSURE OF A DANGEROUS DOG, AND ADANGEROUS DOG, AND ALL REFERENCES THEREIN; PROVIDING FOR AN APPOINTMENT OF A PRIMARY SPECIAL MAGISTRATE, AND TWO ALTERNATE SPECIAL MAGISTRATE, PROVIDING THE DEFINITION OF PRIMARY SPECIAL MAGISTRATE; ESTABLISHING THE CONDUCT OF HEARINGS BEFORE THE SPECIAL MAGISTRATE; PROVIDING THE PROCEDURAL PROCESS FOR UNCLASSIFIED DOGS THAT CAUSE DEATH; PROVIDING FOR ANTON AND QUARANTINE LOCATIONS OF DANGEROUS DOGS; EXEMPTIONS; APPEALS; UNLAWFUL ACTS; AND PROVIDING FOR AN EFFECTIVE DATE.
