Consideration: Request for a Shoreline Alteration/Dredge and Fill Permit SADF # 22-05-017 to authorize the construction of a replacement vinyl seawall, faced with riprap and plantings, along the shoreline of the property; pursuant to Orange County Code, Chapter 33, Article IV, Windermere Water and Navigation Control District
