## **ACTION REQUESTED:**

Approval to award Invitation for Bids Y20-1071-WA, Operable Partition Maintenance, to the low responsive and responsible bidder, Hufcor, in the total estimated contract award amount of \$1,822,710 for a three-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

# PROCUREMENT:

This contract will provide maintenance services and semi-annual inspection to repair and maintain operable door partitions located on both campuses of the Orange County Convention Center (OCCC). These partitions are installed and removed by OCCC staff and must be maintained in a safe and functional manner. Additionally, these partitions are a critical asset to meeting the operational requirement for clients of the OCCC.
