ACTION REQUESTED:

Approval to award Invitation for Bids Y24-117-MV, Tree Trimming and Related Services for Parks and Recreation Division, to the three low responsive and responsible bidders, Seay Tree Service, Inc., in the estimated contract award amount of \$540,375 for a one-year term, J & J's Lawn and Tree Service, Inc., in the estimated contract award amount of \$541,035 for a one-year term, and National Storm Recovery, LLC. dba Central Florida Arborcare, in the estimated contract award amount of \$620,570 for a one-year term. Further request Board authorization for the Procurement Division to renew the contracts for four additional one-year terms.

PROCUREMENT:

The contracts providing tree trimming and the removal of dead or diseased trees is necessary to alleviate dangerous situations in County parks. Additionally, tree canopies need to be elevated and overgrown areas must be cleared to allow for safer recreational activities.

FUNDING:

Delivery orders will be issued from account number 1050-068-1805-3197.

APPROVALS:

The Parks and Recreation Division and Business Development Division concur with this recommendation.

REMARKS:

Twelve bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bids submitted by Aero GroundTek, LLC and A Sun State Trees, Inc. were deemed non-responsive for failing to submit a complete bid package. Seay Tree Service, Inc., J & J's Lawn and Tree Service, Inc., and National Storm Recovery LLC dba Central Florida Arborcare have the necessary manpower and equipment to perform this contract. Additionally, their bids are considered reasonable based on the historic prices and current contracted rates. All recommended bidder's references were verified and demonstrated satisfactory performance. Therefore, award is recommended to Seay Tree Service,
