Applicant: Eric Warren, Poulos & Bennett, LLC, Spring Grove – Jaffers Planned Development / Phase 3 – Parcel W-16 & a portion of Parcel W-17 Preliminary Subdivision Plan / Development Plan, Case # PSP-18-11-384

Consideration: Spring Grove – Jaffers Planned Development / Phase 3 – Parcel W-16 & a portion of Parcel W-17 Preliminary Subdivision Plan / Development Plan, Case # PSP-18-11-384 submitted in accordance with Orange County Code, Chapter 34, Article III, Section 34-69 and Chapter 30, Article III, Section 30-89; This request is to subdivide 65.98 acres in order to construct 169 single-family residential dwelling units and Park Tracts P-3, and P-4.
