ACTION REQUESTED:

Approval to award Invitation for Bids Y19-747-RC, Sheriff's IT Service Area Remodel, to the low responsive and responsible bidder, Core Engineering & Construction, Inc. in the total contract award amount of \$491,500.

PROCUREMENT:

The project includes construction services to demolish and remodel several areas identified within the second floor of the Orange County Sheriff's Information Management Services. The project is located in District 6.

FUNDING:

Funding is available in account number 1023-023-0144.

APPROVALS:

The Capital Projects and Business Development Divisions concur with this recommendation.

REMARKS:

Six bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted from Core Engineering & Construction, Inc. is considered reasonable based on comparison to the engineer's estimate. References provided were satisfactory for this type of work and Core Engineering & Construction, Inc. has been determined to be responsible. Therefore, award is recommended to Core Engineering & Construction, Inc.

PROJECT: Y19-747-RC / Sheriff's IT Service Area Remodel

The Business Development Division evaluated the 3 lowest bids of the 6 bids submitted for this project and found that the apparent low bidder Core Engineering & Construction, Inc. achieved good faith effort documentation and reported 16.08% M/WBE participation in their bid. Please note the following certified M/WBE participation:

The second low bid submitted by Boulevard Contractors Corp. met the M/WBE participation goal and reported 30.47% M/WBE participation in their bid.

The third low bid submitted by Orange County M/WBE firm EPS Contractor Group, Corp. is bidding as a prime. Therefore, EPS Contractor Group, Corp. is required to self-perform no less than 51% of the contract per Sec. 17-321 in the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 25% M/WBE goal. EPS Contractor Group, Corp. reported self-performing 51%. They reported 18.40% other M/WBE participation in their bid and met the M/WBE participation goal.

None of the bids were within the M/WBE sliding scale range to be awarded this contract over the low bidder.
