WHEREAS, the Deed conveyed certain real property, more particularly described on the attached and incorporated Exhibit "B" (the "Property") to the County; and

WHEREAS, the Deed was recorded without approval by the Board as required by Resolution No. 86-M-44; and

WHEREAS, the Board has reviewed the Deed and desires to accept the instrument by this Resolution in fulfillment of Resolution No. 86-M-44.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. The foregoing premises are true and correct and incorporated herein by reference.

Section 2. Although the Property was not previously accepted by the Board as required by Resolution No. 86-M-44, the Board now hereby ratifies such conveyance and accepts the Property conveyed to the County by the Deed.

Section 3. The manager of the Orange County Real Estate Management Division, or a designee, shall provide a copy of this Resolution to the Property Appraiser of Orange County, Florida for the records of that office, and shall record this Resolution in the Official Records of Orange County, Florida.
