Applicant: Major Stacy, Lake Steer Subdivision Preliminary Subdivision Plan; Case # PSP-18-09-295, submitted in accordance with Orange County Code; Chapter 34, Article III, Section 34-69 and Chapter 30, Article III, Section 30-89; This Preliminary Subdivision Plan (PSP) is a request to subdivide 16-96 acres in order to construct 13 single-family residential dwelling units; This request also includes the following waivers from Orange County Code:
