Managerial Appointment - Fiscal & Business Services Division

Manager, County Administration

Following the recent retirement of Fred Winterkamp on September 30, 2023, I am appointing Stephanie Taub as the Manager of Fiscal & Business Services and seeking confirmation of this appointment by the Board of County Commissioners.

Stephanie Taub has been a dedicated and exemplary Orange County Fiscal and Business Services member for more than 21 years. She has held various positions, including Senior Fiscal Analyst and Fiscal Administrator, and then progressed to the role of Assistant Manager in 2007. Ms. Taub has been involved in the County's debt issues during her tenure, leading many of the finance teams. Ms. Taub has served as the leader of the County groups responsible for the issuance of 30 bond deals, including 23 refunds resulting in over \$25 million in net present value savings for the County. She has also coordinated the FEMA reimbursement processes for four hurricanes, resulting in nearly \$100M in reimbursements to the County. She has been the staff lead on the Tourist Development Grants Application Review Committee (ARC), which allocated over \$55M in grants for arts and cultural facilities. Most recently, Stephanie has been involved in reviewing the TDT Project Funding Proposal and Task Force Recommendations. In addition, Ms. Taub has been the project leader for the Financial Empowerment Center, scheduled to be launched in 2024.

Prior to her tenure with Orange County Government, Stephanie worked in the private sector for Kirchman Corporation as well as the Institute of Internal Auditors.

Ms. Taub holds a master's degree in Business Administration from the University of Miami, specializing in finance and marketing, and received the Dean's Award of Academic Merit. She is a Certified Government Finance Officer (CGFO) and graduated from the Orange County Mayor's Executive Leadership Program in 2022.

Ms. Taub's appointment will be effective the first full pay period after Board approval at an annual salary of \$152,542.20.
