ACTION REQUESTED:

Approval of Amendment No. 4, Contract Y19-2038, Reading/Math Coaches – Sector Two, with City Year, Inc., in the amount of \$200,000, for a revised estimated contract amount of \$500,000.

PROCUREMENT:

This amendment will extend the contract for the period of September 1, 2022 through December 31, 2022 to align contract dates, and provide additional funding for the extension period. The alignment will allow these contracts to provide continuity of services accompanied by calendar year funding.

APPROVALS:

The Citizens' Commission for Children Division concurs with this recommendation.

REMARKS:

On August 20, 2019, the Board authorized award of Contract Y19-2038 to City Year, Inc., in the amount of \$300,000. City Year, Inc. is currently providing satisfactory services to provide programming that will assist students who are suspended from school through providing a safe, nurturing environment where students will be supervised by a team of adults, receive access to their school assignments, gain life and social skills training and be treated with respect and dignity. The purpose of this contract is to provide health and human services to children and families throughout Orange County.
