The Orange County Sheriff's Office is requesting \$10,000 from the FY 2021 Law Enforcement Trust Fund-State Forfeitures for the following purpose:

Contribution:

Harbor House of Central Florida – \$10,000. This organization is committed to providing comprehensive services to victims of domestic violence and to provide Domestic Violence education to Central Florida communities. Due to COVID-19, the Harbor House has not been able to achieve their major fundraiser events this year. Some of the services they provide include a temporary safe shelter, a 24-hour crisis hotline, child, teen, and adult counseling, as well as acting as an advocacy on court and legal issues for thousands of victims of domestic violence each year.

ACTION REQUESTED: Approval for the Orange County Sheriff's Office to spend \$10,000 from the FY 2021 Law Enforcement Trust Fund-State Forfeitures for an eligible contribution to Harbor House.


The Sheriff plans to make purchases from the Law Enforcement Trust Fund for the following items and amounts.

These expenditures are for the purpose(s) indicated below and will not be used to meet normal operating needs:


- 1) School Resource Officers, Crime Prevention, Safe Neighborhood or Drug Abuse Education and Prevention programs
