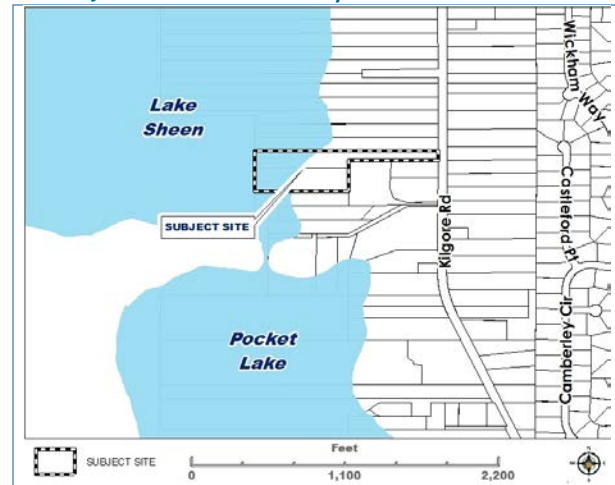

Public Notification Map

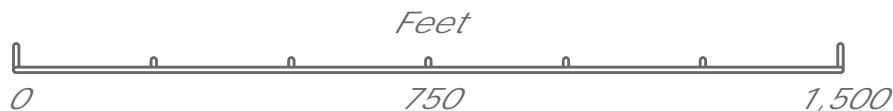
