**Consideration:** A request to change the Future Land Use Map designation from Commercial (C) to Medium Density Residential (MDR); pursuant to Part II, Chapter 163, Florida Statutes and Orange County Code Chapter 30

**Location:** District 3; property located at 4893 S. Orange Blossom Trail; generally located on the east side of S. Orange Blossom Trail, south of Redman Street and north of Americana Boulevard; Orange County, Florida (legal property description on file in Planning Division-see enclosed map)

**Consideration:** An Ordinance pertaining to Comprehensive Planning in Orange County, Florida; Amending the Orange County Comprehensive Plan, commonly known as the "2010-2030 Comprehensive Plan," as amended, by adopting Small-Scale development amendments pursuant to Section 163.3187, Florida Statutes; and providing effective dates.
