Type of Hearing: To amend a Municipal Service Benefit Unit (MSBU) for maintenance streetlighting to include **Foothills of Mount Dora Phase 4 – 1C**.

Hearing Required by F. S.# Florida Statute Sections 125.01 (01) (q) and 197.3632. This public hearing may be scheduled any time prior to May 31, 2025. **The resolution must be approved by May 31, 2025 to be included on the November 2025 real estate tax bill.**

Advertising Requirements / Timeframe: **Publish only one (1) time and must be published at least twenty (20) days prior to the public hearing with the tentative advertisement date as Sunday, March 16, 2025.**

Notify Abutters: Special Assessments will mail public hearing notices to all of the affected property owners.
