PROCUREMENT:

Contract Y19-724-RC was terminated for cause on September 23, 2019 The contractor's bond company's legal counsel has requested the execution of a Release of Claim for the performance and payment bonds associated with this project.

APPROVALS:

The County Attorney's Office and Capital Projects Division concurs with this recommendation.

REMARKS:

On September 12, 2019, the Procurment Division was notified of a Stop Work Request made by the Capital Projects Division. This stop work request resulted in a Termination for Cause pursuant to Article 19 of Contract No. Y19-724-RC. The County terminated its Contract with Brodway Contracting due to contractual violations in accordance with Article 11 and Article 6. The County Attorney's Office, Capital Projects Division, and Brodway Contracting reached a negotiated settlement in the amount of \$70,166.23 for the portion of work deemed acceptable, which has been paid.
