





You are invited to attend and be heard regarding:

Applicant: Eric Warren, Poulos & Bennett, LLC, Spring Grove - Jaffers Planned Development / Phase 3 - Parcel W-16 & a portion of Parcel W-17 Preliminary Subdivision Plan / Development Plan, Case # PSP-18-11-384

Consideration: Spring Grove - Jaffers Planned Development / Phase 3 - Parcel W-16 & a portion of Parcel W-17 Preliminary Subdivision Plan / Development Plan, Case # PSP-18-11-384 submitted in accordance with Orange County Code, Chapter 34, Article III, Section 34-69 and Chapter 30, Article III, Section 30-89; This request is to subdivide 65.98 acres in order to construct 169 single-family residential dwelling units and Park Tracts P-3, and P-4. This request also includes the following waiver from Orange County Code:

1. A waiver from Orange County Code Section 34-152(c) is requested, for Tract R-2 only, to remove the requirement to provide a 20' fee simple access to a paved street, subject to approval by the County Engineer.
