Award of Invitation for Bids Y23-155-TF Sewage Hauling

## **ACTION REQUESTED:**

Approval to award Invitation for Bids Y23-155-TF, Sewage Hauling, to the sole responsive and responsible bidder, Brownies Septic and Plumbing, LLC, in the estimated amount of \$1,200,000 for a one-year term. Further request Board authorization for the Procurement Division to renew the contracts for four additional one-year terms.

### **PURPOSE:**

This contract will provide the hauling of raw sewage from county facilities and various points along the wastewater and reclaimed wastewater infrastructure to approved and regulated dumping locations.

#### **FUNDING:**

Funding is available in account number 4420-038-1347-3197.

#### APPROVALS:

The Field Services Division and Business Development Division concur with this recommendation.

#### **REMARKS:**

One bid was received in response to this Invitation for Bids (IFB) and was evaluated for price reasonableness, responsiveness, and responsibility. Staff evaluated the bid and determined that Brownies Septic and Plumbing, LLC, meets the requirements of the solicitation. All references were contacted, noting reliable and satisfactory performance. Price reasonableness was established by comparison of bid prices to the estimate.

To ensure an open and competitive process, the Invitation for Bids was posted on the County's e-Procurement platform. A query of potential bidders that declined to participate in this procurement resulted in the following findings:

- 1. Manny's Bulk Express dba Greensfields Management: Did not respond to the query.
- 2. EnviroWaste Services Group, Inc.: Did not respond to the query.
- 3. Envirobidnet: Did not respond to the query.
- 4. Lapin Services: Did not respond to the query.
- 5. Avertt Septic Tanks: Stated the scope was beyond their reasonable capacity to withstand.
- 6. Global Concept Enterprise, Inc.: Did not understand the concept of the requirements.
- 7. C&W Global: Inadvertently failed to submit a "No Bid".

Therefore, the award is recommended to Brownies Septic and Plumbing, LLC.
