Consent Agenda Item – February 6, 2024

The National Association of County and City Health Officials, with support from the Centers for Disease Control and Prevention and the National Center for Injury Control and Prevention, has submitted a contract to the Orange County Health Services Department FY23 to continue to support the Implementing Overdose Prevention Strategies at the Local Level Project. The contract is modified to extend the service period from August 1, 2023, through April 30, 2024. The contract will continue to provide funding to expand outreach services to individuals in underserved communities who misuse illicit drugs. The project continues to align with the Office for a Drug Free Community Division's priority areas of expanding access to naloxone, warm hand-off programs, harm reduction programs, and systematic data collection.

On February 7, 2023, the Board authorized award of Contract number 2022-21201, with National Association of County and City Health Officials, in the amount of \$179,397. On October 10, 2023, the Board also authorized the renewal of this contract in the amount of \$116,742.

WHEREAS, the parties entered into Contract # 2022-121201 on the 14th day of February, 2023 and on the 16th day of November, 2023 ("Agreement") and,

WHEREAS, the general purposes of the Agreement are unchanged; and

WHEREAS, both parties wish to make modifications to the Agreement, as described below;

THEREFORE, for the mutual consideration described in the Agreement, the parties agree to the modifications below through the signatures of the person(s) who have the authority to bind the parties to the changes in the Modification:

- 1. <u>Term of Agreement</u>: Article I, Section 2 of the Agreement is modified and shall continue in effect until April 30, 2024, unless earlier terminated in accordance with the terms herein. Expiration of the term or termination of this Agreement shall not extinguish any rights or obligations of the parties that have accrued prior thereto. The term of this Agreement may be extended by mutual agreement of the parties.
- 2. Payment of Services: the updated payment schedule is as follows:

- 3. <u>Scope of Work:</u> The Scope of Work attached hereto as Attachment I to the Modification is incorporated into the Agreement and made a part thereof.
- 4. Domestic Preferences for Procurement Maximizing Use of American-Made Goods, Products, and Materials (E.O. 13881): Executive Order 13881 promotes the Buy American Act, 41 U.S.C. §§ 8301-8305, proposing the policy of the United States to buy American and to maximize, consistent with law, the use of goods, products, and materials produced in, and services offered in, the United States. The proposed rule revives heightened restrictions for commercially available-off-the-shelf ("COTS") products. The Buy American Act ("BAA") restricts the country of origin of goods bought by the U.S. government, requiring the purchase of "manufactured articles, materials, and supplies that have been manufactured in the United States substantially all from articles, materials, or supplies, mined, produced, or manufactured, in the United States." 41 U.S.C. § 8302(a).

Under the current FAR rules (particularly Subparts 25.1, 25.2, and 25.5), a domestic end product is one where: (1) the end-product is manufactured in the United States, and (2) more than 50 percent of the cost of all component parts are manufactured in the United States. FAR 25.101. The agencies anticipated to be impacted by this executive order include the Departments o Defense and Commerce, the National Aeronautics and Space Administration, the General Services Administration (GSA), and the Executive Office of the President. Consistent with this Order, Contractors shall insert the substance of this clause, including this paragraph (c), in all subcontracts.

Pursuant to §200.322, to the greatest extent practicable, provide a preference for the purchase, acquisition, or use of goods, products or materials produced in the United States (including but not limited to iron, aluminum, steel, cement, and other manufactured products which means items and construction materials composed in whole or in part of non-ferrous metals such as aluminum; plastics and polymer-based products such as polyvinyl chloride pipe; aggregates such as concrete; glass, including optical fiber; and lumber).

5. All other terms and conditions of the Agreement remain unchanged.

The National Association of County and City Health Officials (NACCHO), with support from the Centers for Disease Control and Prevention (CDC), the National Center for Injury Control and Prevention (NCIPC), is contracting with local health departments (LHDs) for the Implementing Overdose Prevention Strategies at the Local Level (IOPSLL) project. This project is designed to build capacity for local health departments (LHDs) serving jurisdictions with an above average burden of drug overdose deaths in the following areas:

- Surveillance and Data Sharing
- · Linkages to Care
- Providers and Health Systems Support
- Partnerships with Public Safety and First Responders
- Communication Campaigns
- Stigma Reduction
- Harm Reduction Activities

All contracted LHDs will be expected to integrate a health equity approach in the implementation of their workplans.

The initial contract covered the period from start date to 7/31/2023. The contract was modified to extend through 1/31/2024 per the original project period. This modification extended the contract through 4/30/24 due to administrative and project implementation delays.
