- Final BCC adoption of MSBU rate at first Budget Public Hearing in September




MSBU Background

- Collection compensation in each zone adjusted annually using a CPI formula

MSBU Rate Components

- -Collection
 - Annual hauler payment adjustment for inflation per contract
- –Disposal
 - Annual adjustment based on waste generation by customers
- -Administration
 - Increase for budgeted overhead and personnel costs





MSBU Rate Components, continued

- Recycling Improvement Program
 - Enhanced education
 - Curbside feedback
 - Additional costs caused by contaminated materials in carts
- —Carts
 - Build up funds to buy new carts for next contract
- —Rate Stabilization/Reserves
 - Build up depleted reserves and smooth future rate increases
