#### **RESOLUTION GRANTING PETITION TO VACATE # 18-05-015**

WHEREAS, pursuant to procedures adopted by the Board of County Commissioners, a petition was filed with the Board to vacate that certain portion of 50 feet wide by 120 feet long unopened and unimproved right-of-way known as E 7th Street in Orange County, Florida, as described in attachment.

WHEREAS, notice of a public hearing before the Board of County Commissioners on February 7, 2023, was published in the Orlando Sentinel, a newspaper of general circulation in Orange County, Florida, one time at least two weeks prior to the date for the hearing; and

WHEREAS, the Board finds that the vacating of the portion of 50 feet wide by 120 feet long unopened and unimproved right-of-way known as E 7th Street will not operate to the detriment of Orange County.

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:


