RECOMMENDATION:

Selection of one firm and an alternate to provide Design Services for Orange County Medical Examiner's Office Expansion, Request for Proposals Y24-823-RC from the following firms listed alphabetically:

• Baker Barrios Architects, Inc.

• Gresham Smith

Further request Board authorization for the Procurement Division to negotiate and execute a contract provided that the contract does not exceed the budget of \$2,000,000.

Further request authorization for the Procurement Division to formally terminate negotiations with the top ranked firm, if we are unable to come to a favorable negotiated agreement, and commence negotiations with the next ranked alternate, until a successful negotiation is reached.

This item was evaluated by the Procurement Committee on October 4, 2023. Commissioner Mayra Uribe, was assigned to the Procurement Committee.

PROCUREMENT:

The project is an expansion of the existing Orange County Medical Examiner's facility's existing 41,283 square-foot building located at 2350 East Michigan Street, Orlando, Florida. The consultant shall design a 10,000 to 12,000 square-foot expansion of the existing Medical Examiner's building on an active Orange County campus that services both Orange County staff and Orange County residents. This project is located in District 3.
