All of my clients were chronically homeless, have housing from the public sector but still need monitoring. I would be unique candidate as I provide direct services to those facing affordable housing issues. within the Orange/Tri-County area. Specifically, I have worked at Boys Town, coordinated a non-profit afterschool program and have worked on other projects that focused on children in transition or parent/family development. Currently, I work with the Orlando Children's Church which is a non-profit that transports youth ages 4-18 from urban and rural areas to a facility where they are fed, get to play/be a kid and gain mentorship at no cost to the family. I get to play with the youth but I also serve as a Social Services resource to the organization. Overall, I have been able to see where gaps in services occur especially when it comes to housing, long term care and accessing resources. All in all, I would like to become more involved in my community by lending my technical and professional knowledge of human services and non-profits. I have coordinated a non-profit organization and served as the Treasurer for two organizations. With this, I would like to join the Citize
