The Orange County Corrections Department has applied for and received funding from the U.S. Department of Justice, Bureau of Justice Assistance under the State Criminal Alien Assistance Program. This program reimburses eligible local governments for costs incurred for the incarceration of undocumented criminal aliens. This is the 18<sup>th</sup> year that the Corrections Department has applied for and received funding. The award amount is \$126,366.

## **ACTION REQUESTED:**

Approval of U.S. Department of Justice, Bureau of Justice Assistance grant award under the State Criminal Alien Assistance Program for FY 2021 in the amount of \$126,366 for reimbursement of costs incurred for the incarceration of undocumented criminal aliens. No local match is required.

On behalf of Attorney General Merrick B. Garland, it is my pleasure to inform you that the Office of Justice Programs (OJP) has approved the application submitted by ORANGE COUNTY, FLORIDA for a Payment Award (non-grant) under the funding opportunity entitled 2021 BJA FY 2021 State Criminal Alien Assistance Program Program Requirements and Application Instructions. The approved payment amount is \$126,366.

To access your funds, you will need to enroll in the Automated Standard Application for Payments (ASAP) system, if you haven't already completed the enrollment process in ASAP. The Entity Administrator should have already received an email from ASAP to initiate this process.

The Bureau of Justice Assistance (BJA) is pleased to announce that the Fiscal Year (FY) 2021 State Criminal Alien Assistance Program (SCAAP) awards have been processed and are ready for acceptance in JustGrants and then drawdown in ASAP. The FY 2021 SCAAP award amounts are listed on the <u>SCAAP website</u>. To access FY 2021 SCAAP award funds, entities must assign users in the Justice Grants System (<u>JustGrants</u>), electronically accept the award in JustGrants within 45 days, enroll in the Automated Standard Application for Payments (ASAP) System, and request payment (drawdown) in ASAP by 4-24-23.

**NOTICE:** The application instructions the FY 2021 SCAAP applications correctly identify the fiscal year in the various certifications as "FY 2021"; however, BJA has recently been made aware that, due to a minor technical error, the certifications included as part of the FY 2021 application incorrectly reference "FY2020." By accepting this award, you affirmatively acknowledge that the statements reflected in the certifications apply to FY 2021 <u>only</u> and will be understood by BJA as such. If you intend differently, you must make a separate written affirmative statement to the contrary. That is, for the purposes of FY 2021 SCAAP certifications, every instance of "2020" in the award acceptance in JustGrants should be understood to mean "2021."

Please note that the notification email from JustGrants included standard language that is included in all JustGrants award notification emails. While the Entity Administrator must assign a Grant Award Administrator, Financial Manager, and Authorized Representative for the SCAAP award to be accepted, <u>financial reports</u>, <u>performance reports</u>, and grant award modifications are not applicable to SCAAP. In addition, the award closeout is an automatic process that occurs once the award draw down is conducted in ASAP. No action is required by the recipient to complete the award closeout.
