RECOMMENDATION:

Selection of one firm and an alternate to provide a Special Magistrate for Animal Services, Request for Proposals, Y24-199-AV, from the following firms listed alphabetically:

DHN Attorneys, P.A.

The Law Office of Adolphus Thompson LLC

Further request Board authorization for the Procurement Division to negotiate and execute a contract within a budget of \$153,978 for a three-year term. Further request Board authorization for the Procurement Division to renew the contract for two additional one-year terms.

Further request Board authorization for the Procurement Division to formally terminate negotiations with the top ranked firm, if we are unable to come to a favorable negotiated agreement, and commence negotiations with the next ranked alternate, until a successful negotiation is reached.

PROCUREMENT:

This contract will procure special magistrates for dangerous dog proceedings to be heard as required by Florida Statutes (Sect. 767.12 and 767.13). Since 1996, challenges to an initial determination declaring a dog to be dangerous have been brought to hearing before the quasi-judicial Animal Services Classification Committee. The Committee is comprised of citizen volunteers that are selected by the Board of County Commissioners and serve two-year term lengths.

As the population in Orange County has significantly increased, so has the number of unprovoked dog bites. Therefore, the County feels the interests of its citizens would be better served by utilizing the services of a Special Magistrate to ensure that any challenge to an initial determination of a dog as dangerous is done efficiently and in accordance with state law and Orange County Code.

The Special Magistrate generally shall hear cases in the County Commission Chambers located within the County Administration Center, but other meeting locations within Orange County Government facilities may be utilized, if necessary.
