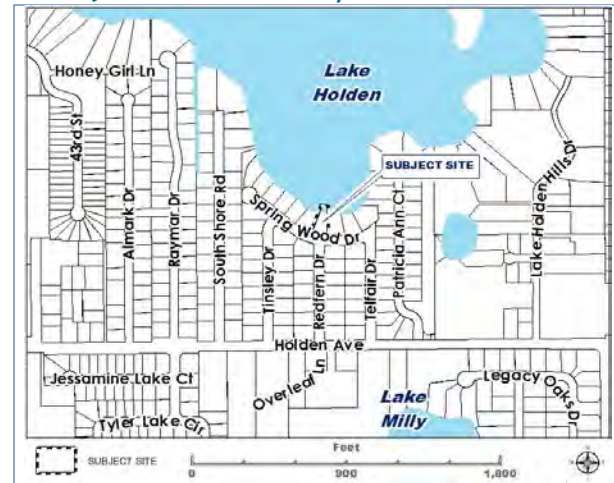

# Public Notification Map

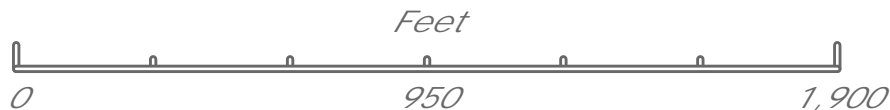
