The U.S. Department of Justice (US DOJ), through the Florida Department of Law Enforcement (FDLE), has allocated \$344,174 to the entirety of Orange County for the Edward Byrne Memorial Justice Assistance Grant – Countywide (JAG-C). The Orange County Sheriff's Office submitted three projects in an application to FDLE totaling \$175,568; the remainder of the allocation went to other Police Departments within Orange County. The first of three projects have now been awarded.

On April 8, 2025, the Board accepted from the US DOJ, through the FDLE, the JAG-C contract #C-6N249 for After-Hour Strike Team Equipment in the amount of \$21,380. The funding will support the procurement of cellphones, cellphone cases, binoculars, and ballistic shields for the After-Hour Strike Team. The award period is from January 1, 2025, to September 30, 2025.

On March 9, 2021, the Board approved the umbrella agreement between the Florida Department of Economic Opportunity and Orange County, which includes the Low-Income Home Energy Assistance Program funding received from the U.S. Department of Health and Human Services. Additional supplemental funding was approved through the Infrastructure Investments and Jobs Act of 2022 in the amount of \$277,686 and will be used to aid lowincome households in meeting their home energy costs. The award period is from July 1, 2023 through August 31, 2025.
