**Consideration:** AN ORDINANCE AMENDING THE ORANGE COUNTY LAW ENFORCEMENT IMPACT FEE ORDINANCE CODIFIED AT ARTICLE II, CHAPTER 23, OF THE ORANGE COUNTY CODE; PROVIDING FOR UPDATED AND INCREASED LAW ENFORCEMENT IMPACT FEES; PROVIDING AN EFFECTIVE DATE AND DIRECTING THE CLERK OF THE BOARD TO PUBLISH A TIMELY NOTICE STATING THAT THE BOARD HAS ADOPTED THIS ORDINANCE IMPOSING INCREASED LAWENFORCEMENT IMPACT FEES, WITH ANNUAL INDEXING.
