ACTION REQUESTED:

Approval to award Invitation for Bids Y21-731-TA, Utilities SCADA Panel Replacement Package One, to the low responsive and responsible bidder, Curry Controls Company in the total contract award amount of \$1,839,000.

PROCUREMENT:

Work under this contract includes Supervisory Control and Data Acquisition (SCADA) panel upgrades to 75 wastewater pump stations throughout Orange County's service area. The upgrade includes the addition of instrumentation to monitor the condition of the pump stations. This project is located throughout all the districts.

FUNDING:

Funding is available in account number 4420-038-1416-0010-6310.

APPROVALS:

The Utilities Engineering and Business Development Divisions concur with this recommendation.

REMARKS:

Four bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bids submitted by Revere Control Systems, Inc. and DSI Innovations LLC were deemed non-responsive for failing to provide a notarized bid form.

PROJECT: **Y21-731-TA / Utilities Scada Panel Replacement Package 1**

The Business Development Division evaluated all two bids submitted for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had no Minority/Women Business Enterprise availability. As a result, the M/WBE goal was reduced to 0%. At the time of bid opening, no M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, submitted by Curry Controls Company, reported 0% M/WBE participation.

The second low bidder, submitted by Prime Construction Group, Inc., reported 0% M/WBE participation.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. Attached is a spreadsheet reconciling the bidders' compliance with the Invitation for Bid's M/WBE requirements, including the percentage breakdown for all bidders and a comparison of the relative bids versus participation percentages.
