Background for the Work Session

 Concern: Residents' complaints about an alleged illegal use of fireworks in a neighborhood

 Goal: To provide for effective enforcement of the State of Florida's provisions related to the permitted use of fireworks in Chapter 791, Florida Statutes

General Statement of the Applicable Law

- Governing Law -- Chapter 791, Florida Statutes
 - regulates the sale, use and storage of fireworks
- Summary of relevant provisions of Chapter 791
 - Requires uniform application throughout the State
 - Defines fireworks as any combustible or explosive composition or substance or combination of substances, except items specifically excluded from the definition of fireworks
 - Provides for enforcement of Chapter 791 by local law enforcement departments and officials charged with enforcement of laws of the State






General Statement of the Applicable Law

Summary of relevant provisions of Chapter 791 (cont.)

- Allows counties and municipalities to adopt reasonable rules and regulations for the granting of permits for the supervised display of fireworks by the following groups:
 - Fair associations
 - Amusement parks
 - Other organizations or groups of individuals
- Does not prohibit the use of fireworks solely and exclusively during the following designated holidays
 - January 1 (New Year's Day)
 - July 4 (Independence Day)
 - December 31 (New Year's Eve)
- Prohibits local governments from adopting regulations and laws (after March 8, 2007) that directly prohibit or interfere with the following:
 - state safety standards, or
 - the right to purchase, sell, use, or possess consumer fireworks

Possible Options for Resolution of the Illegal Use of Fireworks

Three Possible Options for Resolution of Illegal Use of Fireworks

- 1. Enforce Chapter 791, Florida Statutes, without an ordinance
- 2. Enforce the Noise Ordinance prohibitions against noise in excess of allowed sound levels
- 3. Enact an ordinance that incorporates the prohibitions of Chapter 791, Florida Statutes, and that provides the following:
 - a. General prohibitions against the use of fireworks
 - b. Allocates responsibility for noncompliance to individuals
 - c. Provides for enforcement and abatement of the illegal use of fireworks as a nuisance

Key Elements a Proposed Ordinance

Provide general prohibitions against the use of fireworks as follows:

- No person or entity is permitted to use, explode, or discharge fireworks in the county, unless:
 - The person or entity first obtains an appropriate county permit for the display of fireworks or pyrotechnics as provided in Section 21-75 of the Orange County Code of Ordinances; or
 - The use is by a railroad or other transportation agency for illumination or signal purposes, or the use is associated with quarrying, blasting, or another industrial purpose in accordance with Section 791.04, Florida Statutes; or
 - The use is in conjunction with a bona fide agricultural use, as provided in Section 791.07, Florida Statutes.
 - The use is on a designated holiday as provided in Section 791.08 Florida Statutes.



Key Elements a Proposed Ordinance

Designate the prohibited use of fireworks as a nuisance as follows:

 The use of fireworks on a day or in a manner that is not allowed by Chapter 791, Florida Statutes, is prohibited and shall constitute a nuisance

Provide for enforcement of the ordinance as follows:

- Allocate responsibility for noncompliance to individuals
- Provide for enforcement and abatement of nuisance
 - Any person may bring a complaint alleging a prohibited use of fireworks
 - Fireworks complaints would be referred to and received by the Sheriff's Office for personal investigation



Key Elements of a Proposed Ordinance

Enforcement and Penalties

Enforcement and Penalties:

- If the investigating officer finds probable cause to believe a person is in violation of the ordinance, the investigating officer may issue:
 - a written warning for the person to cease and desist the activity, or
 - Issue a citation.
- If the person does not take corrective action to cease and desist from the activity stated in the written warning in a reasonable time, which is defined to mean five (5) minutes or to be immediately, the officer may issue a written civil citation, punishable by a fine as follows:
 - \$200.00 for a first offense
 - \$400.00 for a second offense
 - Up to \$500.00 and a mandatory court appearance for a third offense and each subsequent violation
