Lake Avalon Preservation District Ordinance

District 1

This public hearing is to consider approval of an ordinance to create the Orange County Lake Avalon Preservation District.

The proposed Lake Avalon Rural Preservation District is located in the western portion of the County in District 1. The District is located on approximately 2,236 acres, or 3.5 square miles. The District is considered mostly rural in density, with 1 dwelling unit per 5 acres as the predominant designation.

Residents of the proposed District have met with District 1 Commissioner Nicole Wilson and County Staff on numerous occasions to discuss the possibility of forming the Lake Avalon Preservation District. The goal in doing so is to preserve the rural nature of the community and provide an exclusive procedure for any subsequent voluntary annexations. At the most recent community meeting, which was held on April 27, 2024, residents met with Commissioner Wilson and County Staff to review the proposed Ordinance and discuss the procedure for establishing the District.

Section 171.044(4), Florida Statues, allows charter counties to provide exclusive methods for municipal annexation in their charters. In 1992, Orange County approved a Charter Amendment setting forth an exclusive procedure for voluntary annexations in areas designated by the Board as preservation districts.

Aside from the official designation of the Orange County Lake Avalon Preservation District and the new procedures that would be required for any subsequent annexations of the District, there is no other impact to the District or surrounding area.
