ACTION REQUESTED:

Approval to award Invitation for Bids Y23-7006-EB, Barber Park Drainage Well Replacement and Relocation, to the low responsive and responsible bidder, American Persian Engineering and Construction LLC dba APEC, LLC, in the total contract award amount of \$610,000.

In the event the bidder recommended above fails to achieve timely compliance with pre-award deliverables, as defined in the Invitation for Bids, including, but not limited to, M/WBE participation sub-contract agreements, State Division of Corporations registration, E-verify, insurance and bonds, further request authorization for the Procurement Division to award to the next low responsive and responsible bidder as listed in the bid tabulation herein, to the extent practicable and advantageous to the County.

PROCUREMENT:

This project will address the abandonment of the failing Lake George Drainage Well (B-112) and the construction of a new drainage well in the vicinity of the existing well as it is not practical to rehabilitate the failing well. This project is located in District 3.

FUNDING:

Funding is available in account number 1023-072-2753-6330.

APPROVALS:

The Stormwater Management Division and Business Development Division concur with this recommendation.

The Business Development Division evaluated two bids submitted for this project. The Business Development Division completed a M/WBE Availability Analysis. The scope of services for this project had limited M/WBE availability. As a result, the M/WBE goal was reduced from 25% to 9% At the time of bid opening; at least 66 firms were certified to provide the scope of services at the subcontract level. Both bids included similar scope of services that the Business Development Division used to determine the MWBE goal availability. However, the cost of the line items associated with the scopes of service exceeded the cost of the line items included in the engineering estimate.

The apparent low bid, submitted by APEC, LLC, reported 9.02% in M/WBE participation. The low bid met the Orange County M/WBE participation goal per the Ordinance requirement. Please note the following certified M/WBE participation:

The second low bid, submitted by Henderson Wilder Contracting, Inc reported 28.22% in M/WBE participation. The second low bid met the Orange County M/WBE participation goal per the Ordinance requirement.
