On May 5, 2020, the Board accepted the initial Ambient Air Grant awarded to the Environmental Protection Division, from the U.S. Department of Environmental Protection Agency (US EPA), in the amount of \$35,000 and have since approved amendments No. 1 through No. 3, increasing the total award amount to \$105,000. The US EPA is now awarding amendment No. 4 in the amount of \$35,994, which will increase the total award amount to \$140,994. The budget period for this grant is from April 1, 2020 through March 31, 2024.

The purpose of this funding is to support the ongoing collection of data on the ambient air concentration of fine particulate matter and to support Orange County's efforts with staying in compliance with National Ambient Air Quality Standards.

Therefore, in accordance with Section 129.06(2)(d), Florida Statutes, it is recommended that the following accounts be adjusted by the amounts shown.
