### RECOMMENDATION:

Selection of three firms and an alternate to provide Workers Compensation Legal Counsel Services, Request for Proposals Y20-1091-AH, from the following firms listed alphabetically:

Broussard, Cullen & Blastic, P.A. Dean, Ringers, Morgan & Lawton, P.A. Jones, Hurley & Hand, P.A. Walker, Revels, Greninger & Netcher, PLLC

Request authorization for the Procurement Division to negotiate and execute three, three-year contracts with two additional one-year renewals with the selected firms.

The proposals were evaluated by the Procurement Committee on October 7, 2020. Commissioner Mayra Uribe was assigned to the Procurement Committee.

## PURPOSE:

These contracts will provide legal counsel on workers compensation and other matters to the County's Risk Management Program.

#### DISCUSSION:

Orange County, Tax Collector, Property Appraiser, Supervisor of Elections, Clerk of Circuit Court, Orange Blossom Trail Development Board, and Comptroller are parties to the Interlocal Risk Management and Self-Insurance Agreement. The agreement sets forth the self-insurance program for the Board and the constitutional officers identified above. The implementation and administration of the agreement through the Board, the several constitutional officers, the County's Risk Management Committee, and the Risk Manager or designee is hereafter referred to as the "Program."

The Program is a mechanism through which workers compensation claims are settled, litigated, or denied. The program is administered by the Director of Risk Management and Professional Standards and a third-party administrator responsible for the initial investigation and evaluation of claims.

Selection of Firms, Request for Proposals Y20-1091-AH, Workers Compensation Legal Counsel

The disposition of claims is made by the Director in conjunction with the Risk Management Committee composed of members appointed by the County. This includes claims defense litigation similar to that required by an insurance carrier or large self-insurer. The firms may also provide legal advise and services on related workers compensation matters.

Seven proposals were received in response to the Request for Proposals (RFP). The proposals received from Eraclides, Gelman, Hall & Indek, P.A. and Levy & Levy, L.L.C. scored too low for Board consideration. The proposal received from Quintairos, Prieto, Wood & Boyer, P.A. was deemed non-responsible after having disclosed a conflict of interest which would require a waiver by the County. The RFP specified that firms requiring a waiver from the County shall not submit a proposal.

Consensus scores of the Procurement Committee are attached.
