Approval to award Invitation for Bids Y19-717-TA, Eastern Water Reclamation Facility IRP Electrical System Improvements Project, to the low responsive and responsible bidder, Wharton-Smith, Inc., in the award amount of \$2,647,000.

## **PROCUREMENT:**

This project consists of furnishing and installing four motors and variable frequency drives (VFD), conversion of interior room of the electrical building to HVAC to accommodate the VFD equipment, installation of associated conduit piping, and installation of four aerator starters. This project is located in District 4.

### **FUNDING**:

Funding is available in account number 4420-038-1538-6310.

#### APPROVALS:

The Utilities Engineering Division and the Business Development Division concur with this recommendation.

#### **REMARKS**:

Two bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Eau Gallie Electric, Inc. was determined to be non-responsible for failure to provide similar projects that met the requirements of the Invitation for Bids. Wharton-Smith, Inc. has a satisfactory record of performance and is considered responsible. Therefore, award is recommended to Wharton-Smith, Inc.
